











Minutes of the Online IQAC meeting held on 25 August 2020 at 2.30 pm


The meeting commenced with a silent prayer and Dr. Ranjith Mathew Abraham welcomed the members. The following discussions/ decisions were made.

1. 
ACTION TAKEN REPORT
