Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for disposal of the articles should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/or 'subject to prior sale' condition are liable to be rejected. The acceptance of the quotations will be subject to the following conditions:

- 1. The Reserve Price of the old news papers and magazines Rs.10 per kg and the party quoting the highest rate shall be awarded the auction sale.
- 2. Rates should be quoted on per kg basis separately for News papers and Magazines.
- 3. The successful bidder shall have to deposit the whole amount in cash after proper weighing of the old news papers and magazines on the same days before 3pm.
- 4. Acceptance of the auction amount shall be provisional subject to the approval of the Principal, Bishop Moore College, Mavelikara.
- 5. Successful bidder shall be required to remove the old news papers and magazines from the college central library within 10 working days from the acceptance of the award letter after depositing the total amount calculated weighing on Digital Weighing Machine. (to be arranged by the bidder)
- 6. The intending bidder is advised to visit the College Central Library to satisfy himself/herself regarding location, quality and quantity before participating in the auction.



- 7. It will be the responsibility of the successful bidder to pack the materials by his own labourers and the cost towards transportations, packing, loading, unloading etc. will also be borne by the bidder himself.
- 8. Withdrawal from the quotation after it is accepted or failure to disposal within a specified time or according to specifications will entail cancellation of the offer letter and disposal being made at the offerers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified number of years.
- 9. No representation for enhancement of price once accepted will be considered during the currency of the contract.
- 10. Any attempt on the part of tenderers or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderers.
- 11. If any license or permit is required, tenderers must specify in their quotation and also state the authority to whom application is to be made.
- 12. The quotation may be for the entire or part disposals. But the tenderers should be prepared to carry out such portion of the disposal included in their quotation as may be allotted to them.
- 13. The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the contract.
